SBM to force illegal meat, liquor shops to shut down

Workers of Swarnim Bharat Manch (SBM) and social organisations will ensure that illegal meat and liquor shops within Mahakaleshwar temple region are shut down, on Sunday from 11 am onwards. To encourage public participation in the movement, SBM has called for a bandh from 9 am to 2 pm.

Dinesh Shrivastava of SBM said, "Top officials of Ujjain Municipal Corporation as well as the collector have been issuing orders for the removal of these shops continuously for past few years, but offi cials concerned are ne-glecting the orders forcing us to take matters in

They added that, saint Kamalmuni maharaj visited Ujjain two months ago and staged a dharna at Ramghat to bring the issue to the notice of the administration. UMC commissioner Ashish Singh then assured him of action within seven days. Several months had passed since the dharna but these shops are still being operated illegally.
